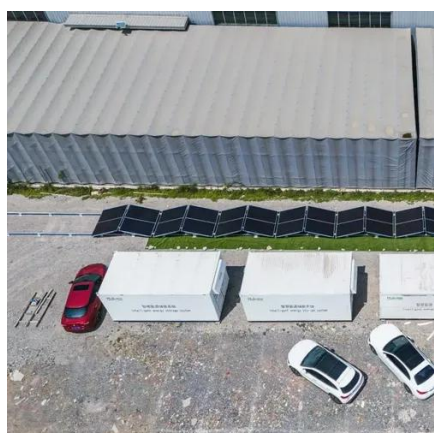


2026 Rental Fee Schedule for Communications Uses
