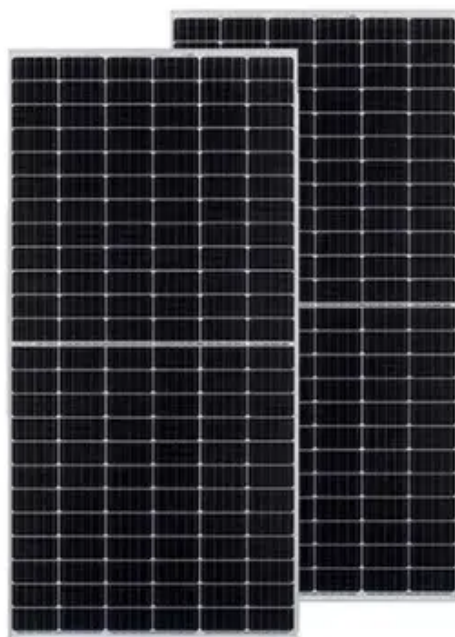




# How is the Sino-German joint venture photovoltaic panel
