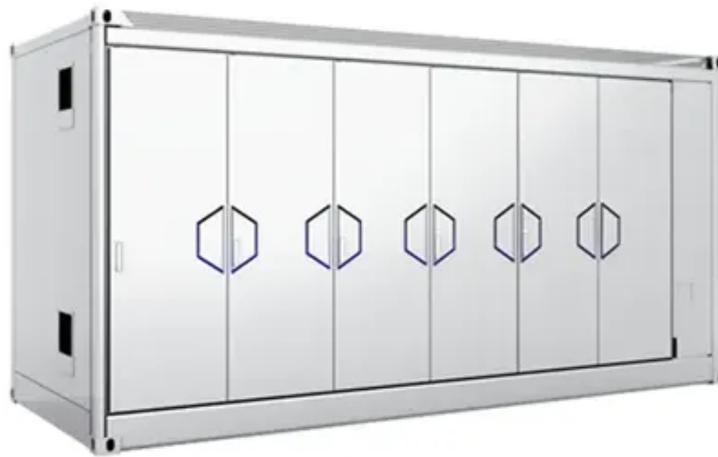




# How to report if photovoltaic panels are not removed




