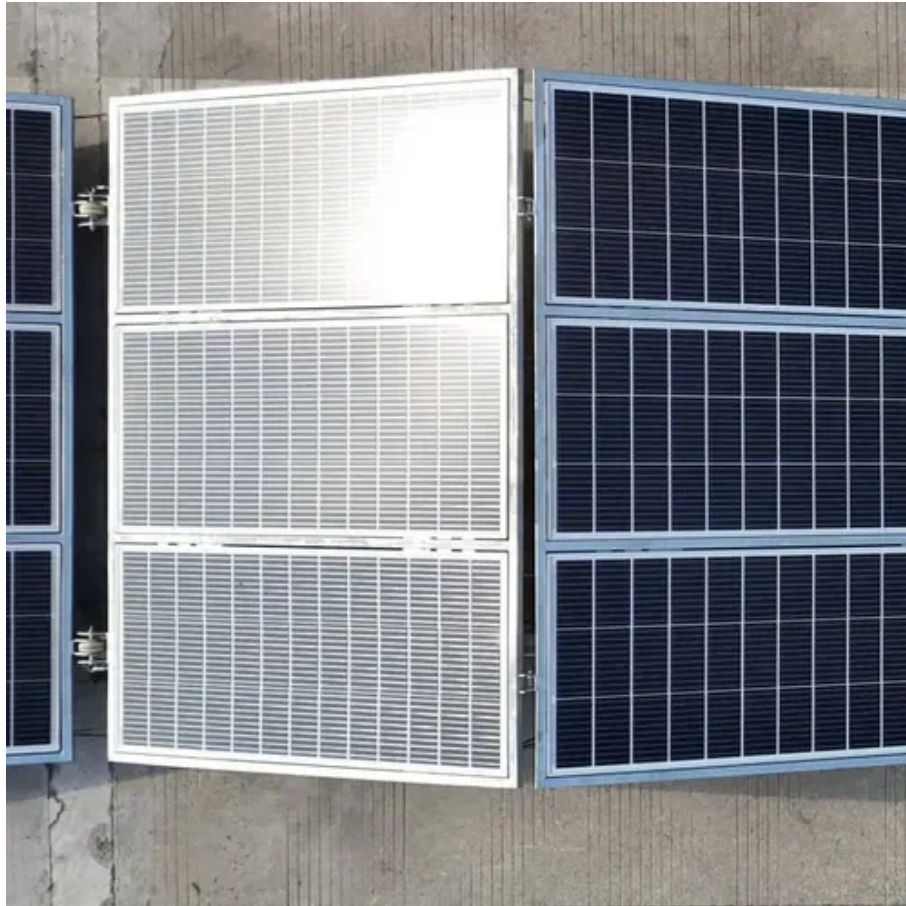




# Mumbai india downgrades pv module exports

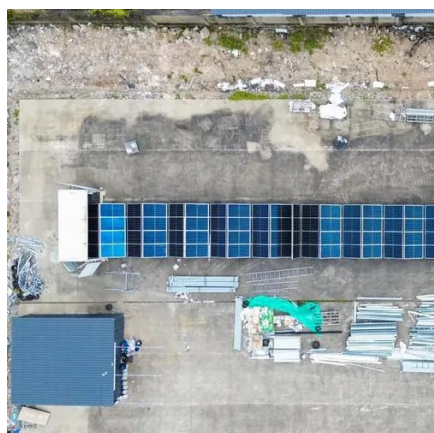
