Overview

EPA is planning to propose new rules to improve the management and recycling of end-of-life solar panels and lithium batteries. EPA is working on a proposal to add hazardous waste solar panels to the universal waste regulations found at Title 40 of the Code of Federal. These laws vary by state, but the moment your solar system is installed and connected, a new legal landscape opens up. The credit amounts and types of qualifying expenses were expanded by the Inflation Reduction Act of 2022. Under this new law, homeowners who purchase their systems with cash or a loan will no longer be eligible for the 30% federal tax credit after December 31, 2025. The federal credits that carried the residential market for a decade are being cut off at the end of 2025, and the new rules born out of OBBBA in mid 2025 do not treat homeowners and commercial players the same.

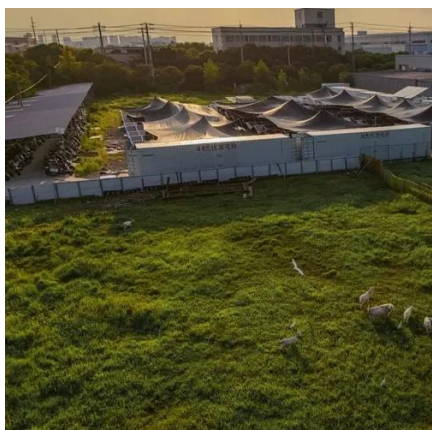

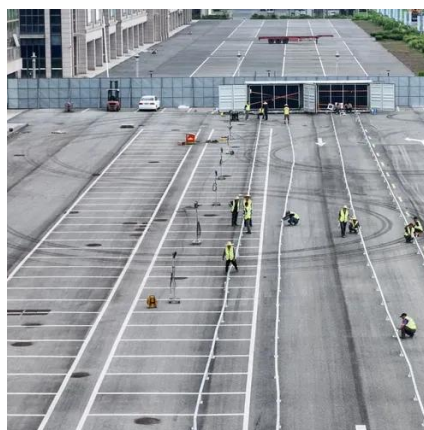
