



Tariffs on the export of solar modules from Krakow Poland





Overview

View Trade Statistics by Country including trade summary, exports and imports by partner and products along with tariff and development indicator. For this purpose, the EU uses the Combined Nomenclature (CN), which is a development of the world harmonized system for marking and coding goods, known as the Harmonized System (HS). The Common Customs Tariff is a combination of the CN goods classification system and customs duties for each class. Solar module prices and overall solar project costs are set to shoot up following the recent import duties on solar glass. Recently, the Centre imposed anti-dumping duty in the range of \$658/MT to \$664/MT for imports from China and \$570/MT to \$664/MT from Vietnam, Mercom reported. Poland has adopted the Common. How much is the export tax on solar panels?

The export tax on solar panels varies significantly based on the country of origin, destination, and the regulations in place at the time of export.
