



VAT rate for photovoltaic bracket sales





Overview

This new paragraph in the VAT Act essentially stipulates that the VAT rate for the supply and installation of certain photovoltaic systems will be reduced to 0%. No VAT will be charged for sales subject to this zero rate. The EU has standard rules on VAT, but these rules may be applied differently in each EU country.

0% VAT for photovoltaic systems

In the case of a solar module for a photovoltaic system, essential components and storage units that meet the legal requirements, the standard rate of VAT is reduced from 19% to 0%. ...

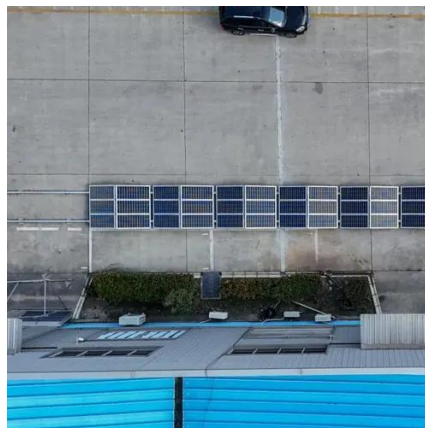
